___ **\$45.00 per hour** for any work or services not covered by another fee below.

___ **\$20.00 per hour** for all telephone calls pertaining to scheduled fees or miscellaneous fee.

SUBDIVISION and LAND DEVELOPMENT:

___ \$500.00 Filing Fee for Subdivision Plans and Land Development Plans

ZONING

ZONING PERMITS (as required by the Township's Zoning Ordinance):

___ \$200.00 for new homes in public sewer areas

___ \$200.00 for non-residential permits (excluding Use & Occupancy) and Concentrated Agricultural Operations structures

___ \$100.00 for new homes with septic

___ \$60.00 for residential additions, inground pools, detached accessory structures over 500 sq. ft., attached garages, decks over 500 sq. ft.

___ \$50.00 for aboveground pools, demolition, patios, detached decks and accessory structures 500 sq. ft. or less, and agricultural structures excluding structures for or at concentrated agricultural operations which shall be non-residential structure(s) (see above)

Construction without a Permit A request to issue a zoning permit to cure a failure to secure a zoning permit at the commencement of construction, the fee will be two (2) times the filing fee if the fee was paid at commencement; each additional thirty (30) days from the mailing of notice to owner/builder to pay doubles the then outstanding amount (if \$10.00 to fee; \$20.00 to cure; 1st 30 days is \$40.00; 2nd 30 days is \$80.00, and so forth)

HEARINGS:

___ **\$1,000.00 for Zoning Hearings or Appeal of Zoning Officer Determination or Interpretation-** Not filed until initial non-refundable fee is paid at the time of filing; any excess costs are billed after termination, or an appealable decision is rendered; no permit will be issued until ALL fees paid; if a zoning officer determination is not upheld the fee is refunded.

- _____ **\$1,500.00 for Petition to Amend Zoning Ordinance or Zoning Map**-Not filed until initial non-refundable fee is paid at the time of filing; any excess costs are billed after termination or an appealable decision is rendered; no permit will be issued until ALL fees paid; .
- _____ **\$1,500.00 Conditional Use Application-**
Not filed until initial non-refundable fee is paid at the time of filing; any excess costs are billed after termination, or an appealable decision is rendered; no permit will be issued until ALL fees paid;
- _____ **\$4,000.00 00 for Commercial or Industrial Use or Structure Zoning Hearings or Appeal of Zoning Officer Determination or Interpretation (does not include Home Occupations)**
Not filed until initial non-refundable fee is paid at the time of filing; any funds not used in excess of \$100.00 will be refunded to applicant; any excess costs above \$4,000.00 are billed after termination or an appealable decision is rendered; no permit will be issued until ALL fees paid; if a zoning officer determination is not upheld the fee is refunded.

SEWAGE ENFORCEMENT REGULATIONS, OFFICER FEES and TOWNSHIP ADMINISTRATION FEES

Site Evaluation Stage:

Applicant is responsible for contacting a contractor to schedule the deep probe. A time will be scheduled when the Applicant, the Sewage Enforcement Officer (SEO), and the Applicant's Contractor with a backhoe can meet on the site. One or more seven foot deep test pits will then be dug. The holes will be evaluated and closed on that same date.

Applicant is responsible for digging and soaking the perc holes. The depth of the holes will be determined upon completion of the probe analysis.

Upon completion of the soils testing, the SEO will notify applicant in writing regarding the results of the soils testing. This notification should not be construed as a guarantee of permit issuance

The Applicant is responsible for ensuring that all underground utilities are marked after calling PA One Call System @ 1-800-242-1776.
